Members Report Activities

Claude Cazalé Bérard is preparing a book, Genealogie del racconto, on medieval narrative structures in Italian literature. She has already published two books (and numerous essays) of interest to ABA members: Stratégie du jeu narratif: le Décaméron, une poétique du récit (Paris, 1985) and Les Métamorphoses du récit, conteurs, prédicateurs, chroniqueurs des XIIIe et XIVe (Paris, 1987).

Victoria Kirkham is at work on a book, Boccaccio's Tuscan Muse, a literary portrait of the poet with a focus on the Filocolo. A collection of her essays, The Sign of Reason in Boccaccio's Fiction, has appeared (Florence: Leo S. Olschki, 1993), as has a review of Giuseppe Mazzotta's The World at Play in Boccaccio's Decameron, in Renaissance Quarterly 47.3 (Autumn 1994): 653-56. In May she presented a paper, "Breve storia del Chianti 'Boccaccio'' at the AISLLI in Turin; the paper is forthcoming in the acts of the conference, to be published by Olschki.

Karl-Ludwig Selig has edited *Polyanthea: Essays in Art and Literature in Honor of William Sebastian Heckscher* (The Hague: Van der Heijden Publisher). Contributors include Jan Baptist Bedaux, Horst Bredekamp, Anna C. Esmeijer, Ulrich K. Goldsmith, Eddy de Jongh, Karen Michels, Karl-Ludwig Selig, Pierre Vinken, and Martin Warnke. Members wishing to order a copy (\$35) may address the publisher at Statenlaan 89, 2582 GE The Hague, The Netherlands. Prof. Selig recommends library acquisition of this *Festschrift* as well.

Marilyn Migiel is preparing a feminist reading of the *Decameron*.

Diane Vacca's essay, "Converting Alibech: 'nunc spiritu copuleris," is forthcoming in *Journal of Medieval and Renaissance Studies*. She reports that she hopes soon to finish her booklength study on Boccaccio.

The Boccaccio Association will sponsor a session at the Thirtieth International Congress on Medieval Studies, May 4-7, 1995 at Western Michigan University, Kalamazoo. Speakers include Myriam Swennen Ruthenberg, Florida Atlantic Univ., giving a *Lectura Boccaccii* on *Decameron* 3, 6, and Victoria Kirkham, Univ. of Pennsylvania: "Paschaltide Passions: Petrarch's Debt to Boccaccio's Fiammetta."

The fifteenth annual conference of the American Association for Italian Studies, April 20-23 1995, at Arizona State University, Tempe, will include a session on Boccaccio sponsored by the Association. Speakers are Maria Bendinelli Predelli, McGill Univ.: "Medieval Misogyny and the Virtue of Zinevra"; David Salgarolo, Dickinson College: "Representation and Marginalization of the 'Other': Revisiting Abraam and Melchisedech"; Gloria Allaire, Ohio Univ.: "The Written Eloquence of Frate Cipolla (*Decameron 6*, 10)"; and Luisella Bovio Arnold, Univ. of California, Santa Barbara: "Riscritture apuleiane: le metamorforsi di Psiche nella *Genealogia deorum gentilium* di Giovanni Boccaccio."

Profs. Claude Cazalé Bérard (Univ. Charles De Gaulle) and Michelangelo Picone (Univ. Zürich) have organized an international seminar on Gli Zibaldoni di Boccaccio: Memoria, scrittura, riscrittura, which will take place in Florence from April 26-28, 1996. The organizers write: "Il Seminario proposto vuole essere l'occasione di riunire intorno ad una specifica tradizione testuale studiosi appartenenti a diverse discipline umanistiche, dalla codicologia alla filologia, dalla critica letteraria all'antropologia storica. Gli zibaldoni (Laurenziano XXIX-8 e Magliabechiano II II 327) e la miscellanea (Laurenziana XXXIII.31), prescelti per la loro diversa e complementare tipologia scrittoria, nonché per la loro problematicità metodologica ed ermeneutica, dovrebbero consentire di confrontare principi di analisi e metodi di approccio, per lo più applicati separatamente nell'ambito di indagini specialistiche rivolte via via al Boccaccio copista, editore, autore, commentatore. Infatti, il convergere delle problematiche non può che giovare alla messa in luce dell'opera di divulgazione culturale del Nostro, e del suo ruolo di sperimentatore e teorizzatore di un nuovo statuto della letteratura come vocazione e come mestiere. Si propongono, quindi, tre campi di ricerca da affidare a coordinatori e gruppi di studiosi, invitati a collaborare nella preparazione del Seminario: (1) il sistema del sapere e la biblioteca ideale di Boccaccio; (2) il sistema della scrittura; (3) il sistema intertestuale e la strategia della riscrittura."
