

# **Honorary Members**



### Lucia Battaglia Ricci

Lucia Battaglia Ricci taught Italian Literature at the Università di Pisa and Roma Tre. Her main area of expertise is medieval vernacular literature, in particular its relation with the visual arts. She has authored and edited more than a dozen books and edited volumes, including Dante e la tradizione letteraria medievale (Pisa, Giardini 1983); Ragionare nel giardino. Boccaccio e i cicli pittorici del 'Trionfo della Morte' (Roma, Salerno Ed. 1987 e 2000); Palazzo Vecchio e dintorni. Studio su Franco Sacchetti e le fabbriche di Firenze (Roma, Salerno Ed. 1990: Menzione speciale Premio Salimbeni 1992); Parole e immagini nella letteratura italiana medievale (Pisa, GEI 1994); Boccaccio (Roma, Salerno Ed. 2000); Scrivere un libro di novelle. Giovanni Boccaccio autore, lettore, editore (Ravenna, Longo 2013). She prepared an edition of Dante's Inferno for Franco Maria Ricci-Art'è (2004). She has also prepared a history of the visual tradition of the Commedia, titled Dante per immagini. Dalle miniature trecentesche a oggi, which is forthcoming in 2018 with the prestigious Saggi Einaudi series. She was awarded the Ordine del Cherubino on Feburary 15, 2009.

## Cormac Ó Cuilleanáin

Cormac Ó Cuilleanáin was educated in Cork, Dublin, Cambridge and Florence. He retired from Trinity College Dublin in September 2016, after more than 30 years' service in the Department of Italian. His main areas of research are Boccaccio, translation, Dante, and creative writing (especially fiction). He has published extensively on medieval Italian literature, starting with his 1984 monograph Religion and Clergy in Boccaccio's Decameron (Rome: Edizioni di storia e letteratura, 1984). He has also worked on several edited collections of research, including Dante and the Middle Ages: Literary and Historical Essays, co-edited with John Barnes (Dublin: Irish Academic Press, 1995); Patterns in Dante: Nine Literary Essays, co-edited with Jennifer Petrie (Dublin: Four Courts Press, 2005). One of his larger projects was a new English version of Boccaccio's Decameron, based on John Payne's 1886 translation (Ware: Wordsworth Editions, 2004). Recently, he contributed an essay on "Translating Boccaccio" to the Cambridge Companion to Boccaccio (2015).
