## Message from the President

Dear Colleagues,

At the time of our last newsletter in Fall 2020, we were bracing ourselves for the future onslaught of our "pestiferia infermità," and rightly so. According to the Johns Hopkins University database, the novel coronavirus has claimed a total of 3.94 million lives worldwide. In November 2020, the United States surpassed the threshold of 250,000 fatalities from COVID-19. The disease has now taken 604,000 lives in the United States alone, and 128,000 lives in Italy. We have suffered immeasurable loss during the past eighteen months.

In stark contrast with this loss, there is also a vitality newfound interconnectedness flourished in our community over the past year. Technology has facilitated the forging of new connections and nourished existing collaborations. During the past several months, we have taken part in an overwhelming number of virtual conferences and seminars that have featured Boccaccio's works and times. I am very proud of the many efforts by this Association to create such opportunities, and thank my fellow officers — Valerio Cappozzo, Vice-President; Maggie Fritz-Morkin, Secretary; and Elsa Filosa, Treasurer — for their tireless work that has brought these different ideas to fruition.

Foremost are two ABA programs that have originated in this pandemic year. Both have met with great success: the "Virtual Brigata" series and the Online Summer Paleography Seminar.



The Virtual Brigata is a series of monthly lectures on research-in-progress that deals with any topic related to Boccaccio's life and works. We thank Alyssa Granacki, Teresa Nocita, Alyssa Falcone, Olivia Holmes, Virginia Machera, Valerio Cappozzo, Albert Ascoli, Carmen Blanco Valdés, and Grace Delmolino for their excellent presentations. We have been delighted with the high level of these talks, the strong attendance and copious comments and feedback that have been offered at these monthly meetings. We look forward to continuing this successful series during the 2021-2022 academic year. Please consider participating by proposing to present your current work with our ABA community.

This summer we launched our first paleography seminar, titled Manuscript Culture in Boccaccio's Times, which was organized by the American Boccaccio Association together with the generous support of the Ente Nazionale Giovanni Boccaccio, as well as the organizational and technological support of the Center for Medieval Studies at Fordham University. This online seminar was the fruit of a collaboration between representatives of ABA, namely Valerio Cappozzo, current Vice President and former Secretary of ABA; Susanna Barsella, Professor of Italian at Fordham University, and former Vice President of ABA; and Elsa Filosa, current Treasurer, and former two-term Secretary of ABA. Together with Professors Irene Ceccherini, Marco Cursi, Teresa De Robertis, Maddalena Signorini, and Stefano Zamponi, they initiated the planning for this "scuola estiva" on Boccaccio paleography back in the Fall of 2019, with the intention of bringing students from North America to various libraries in Rome, the Vatican City, and Florence, who would learn from these masters onsite in June 2020. Of course, no one knew back then what 2020 would bring.

We heartily thank Professors Ceccherini, Cursi, De Robertis, Signorini, and Zamponi, for guiding our seminar participants in the methodological and practical elements of Latin and vernacular paleography, and for taking us on a virtual tour through the Angelica, Corsini and Vallicelliana libraries in Rome; the Vatican Library; the Riccardiana, Laurenziana, and Central National Libraries in Florence.

Based upon these successes, we have also initiated a new online program: the Member Book Launch series. This virtual series features new books authored or edited by Association members. Books that have been released within the previous two years and the current calendar are eligible for inclusion in the series (from 2019 onwards). These presentations are approximately thirty minutes in length, followed by a question-and-answer session with the audience, and may be held in English or Italian. In the case of an edited collection, editors may arrange for a roundtable discussion with a selection of the contributing authors. This series was inaugurated by Dino Cervigni with a presentation of his book, "Boccaccio's Decameron: Rewriting the Christian Middle Ages and the Lyric Tradition" (ACMRS, 2021). The second book presentation in this series was Niccolò Acciaiuoli, Boccaccio e la Certosa del Galluzzo: Politica, religione, ed economica nell'Italia del Trecento (Viella, 2020), edited by Alessandro Andreini, Susanna Barsella, Elsa Filosa, Jason Houston and Sergio Tognetti.

Much of our normal programming and activities continue, from sponsored sessions at the MLA and RSA conventions, to the support of undergraduate, graduate, and creative work by means of the Giuseppe Velli Prizes. Our Lectura Boccaccii series, published with the University of Toronto, was featured during a special panel discussion in May. This event, sponsored by UTP, featured Suzanne Rancourt, the Manager of Humanities Acquisitions at UTP, and the editors of Days Four, Six, and Eight: Michael Sherberg, David Lummus, and William Robins.

We have more good news to share on the LB series front: "The Decameron Day Six in Perspective", edited by Lummus, is hot off the press! I am also pleased to announce that the volume on Day Nine, edited by Susanna Barsella and Simone Marchesi, will also be published within this calendar year. The remaining volumes of the series (Days Two, Five, Seven and Ten) are all making steady progress towards completion.

Our website has gone through a series of challenges these past several years, but we are happy to report that former ABA President Michael Papio is in the process of rebuilding it to be even better than ever. Michael will serve as the ABA Web Developer, and we are infinitely grateful to him for graciously volunteering his expertise at no cost to the Association. Grazie infinite, Michael!

Last, and by no means least, we are planning for our upcoming Triennial Conference, to be hosted by the University of Padua, June 6-8, 2022. We are indebted to our colleagues in Padua, especially Rino Modonutti, for creating this opportunity for us to unite in Italy after such difficult times. We are excited to announce our four keynote speakers for this event: Lucia Battaglia Ricci, Theodore Cachey, Cormac Ó Cuilleanáin, and Gina Psaki. Please read ahead in this newsletter for our call for papers. Join us in Padua! We will offer travel scholarships for graduate students and contingent faculty members to help with the costs of international travel.

The ABA is fortunate to have such a vibrant and supportive membership. We thank all of you for donating your time, energy, ideas, and resources to make it such a successful and productive association.

I look forward to seeing you in Padua!




**Cervigni, Dino S**. Boccaccio's Decameron: Rewriting the Christian Middle Ages and the Lyric Tradition. ACMRS 2021.

The monograph develops a new interpretation of the Decameron, a masterpiece which has found renewed popularity in the wake of COVID. The author offers an all-inclusive, unified, and novel reading of the masterpiece, emphasizing the essential nature of the ten evening ballads and showing that the first ninety tales of the Decameron offer a parodic rewriting of the Christian Middle Ages, while the last ten tales craft a reconstruction of society based on human and liberal principles such as secular generosity and sacrifice. The ten evening songs, likewise, rewrite all topoi characteristic of dolcestilnuovo poetry.



Preeshl, Artemis. Consent in Shakespeare: What Women Do and Don't in Shakespeare's Mediterranean Comedies and Origin Stories. Forthcoming from Routledge in September 2021.


This refreshing take on Shakespearean comedy and tragicomedy in the Early Modern Mediterranean promotes heightened awareness of intersection of identities in consent-based practices in the academy and entertainment industry. Boccaccio scholars will appreciate Chapter 6, "Is all well on love's pilgrimage? Boundary crossings between the sheets," which discusses Boccaccio's "Gilletta of Narbonne" in relation to All's Well That Ends Well. Additionally, Chapter 7, "Measuring consent: The consequences of "yes," "no," and "no, but...", discusses Boccaccio's "Titus and Gisippus."






The Decameron: Fourth Day in Perspective. Ed. Michael Sherberg.
